Discounts

The school offers discounts to parents who enrol at least two children at the school. Discounts are also referred to as Sibling Discounts and only apply to tuition fees.

Sibling Discounts are 5% off the applied published tuition rate for the second child and 10% off the applied published tuition rates for the third and subsequent children. For the avoidance of doubt, to be considered for Sibling Discount, both students must be full fee-paying students.

For **Founding Students** only, the sibling discount will be in addition to the Founding Student Annual Fee Discount.

Referral Rewards

To help us spread the word about Charterhouse Lagos, we are offering, for a limited period, the opportunity for fully signed up parents to benefit from our Referral Rewards scheme; -

1. The students' fee account will be credited with N2m for each student a parent recommends and results in a student enrolling and paying a minimum of one term's fees.
2. There is no maximum for the number of Referral Rewards a parent can claim
